**Hire of Ring Fencing**

This agreement, which should be sent initially to the BGV Club Show Manager, is between the Basset Griffon Vendéen Club, (the Owner), and ....., (the Hirer). It contains details of the Equipment, the Hire Agreement, Carriage of the Equipment, the Responsibilities of the Hirer and of the Owner and the Hire Charge.

**2. HIRE AGREEMENT**

**2.1 The Hire Period** - The Hirer will rent the ring fencing for the specified Hire Period.

**2.2 Extension of the Hire Period** - The Hire Period may be extended by agreement. This must be done in writing before the initial Hire Period (or any extended period) expires.

**3. RESPONSIBILITY OF THE HIRER**

The Hirer is fully responsible for the ring fencing whilst it is in his possession and must maintain the ring fencing in good condition. The Hirer will indemnify the Owner for loss or damage.

**4. RESPONSIBILITY OF THE OWNER**

The Owner cannot accept responsibility if the fencing is unavailable due to damage or non-return by the previous Hirer or for any other reason.

**5. THE HIRE CHARGE AND PAYMENT**

This sets out the payment terms. Payment is to be made at least one calendar month in advance of **£50.00** for up to 6 days hire of fencing sufficient for one ring, **£80.00** for up to 6 days hire of fencing sufficient for two rings. Any extension of the hire period will attract a charge of **£10.00** per day which must be paid for by cheque before expiry of the extension period. In addition **the Owner** requires **the Hirer** to provide, at least one calendar month in advance, a further separate deposit of £100 by cheque made payable to the Basset Griffon Vendéen Club. This will be given back on return of the equipment in good order and with no parts missing. Should any damage or part or parts missing be identified, the deposit will be forfeited to cover the cost of repair or replacement. **The Hirer** will be responsible for any shortfall should the cost of repair, or replacement, exceed the deposit paid.

**6. CARRIAGE OF THE EQUIPMENT**

Unless specific prior arrangements are made with **the Owner**, **the Hirer** will collect the ring fencing from **the Owner**. Collection, return and all transport costs incurred by **the Hirer** will be at **the Hirer's** own expense.
